  Materials Below State minimums would get 70,000 dollar cut by the State.
- > 5,000 less electric, water, sewage by being closed those days. Do not keep Part-time library assistant. Maintain services and employees vs hours and materials. Nights open could be cut and would lead to reduction in teen programming and evening hours, all part of assistants job.
